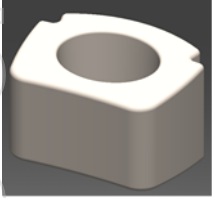

## Allegra Announces new

### Head of Technology and Innovation

SYDNEY 19<sup>th</sup> April 2021– Allegra Orthopaedics Limited (Allegra) (ASX: AMT) is pleased to announce it has engaged Robert Bell to lead the Technology and Innovation Division.

Based in the USA, Robert’s primary responsibility will be overall management of Allegra’s flagship innovation project, the Sr–HT–Gahnite Spinal Cage Device (Spinal Cage).
